4. **RANDOM DRAWING:** Winners of the Grand Prizes will be selected from among all eligible entries via a random drawing to be conducted on June 25, 2024, at 10:00 a.m. Eastern Time. Each Grand Prize winner without an existing Florida 529 Savings Plan account will need to complete and submit an application within 3 calendar days of being notified that they were selected as a winner.

Each Grand Prize winner must choose an individual from the ages of newborn through 8th grade as the beneficiary of the Plan. The beneficiary must also be a Florida resident for whom the winner expects to use the prize proceeds to help cover qualified higher education expenses at an eligible institution.

Winners of Grand Prizes will be notified by July 17, 2024, by email and/or phone at the email address and number provided on the entry form. If a prize or prize notification is returned as unclaimed or undeliverable to a winner, or if winner cannot be reached within 72 hours from the first notification attempt, then such person shall forfeit the Grand Prize.
